FAKTOR-FAKTOR PENGGUNAAN ALAT PELINDUNG DIRI (APD) PADA PEKERJA UNIT EXTRUDER DI PT. FEDERAL PLASTIK INDONESIA TAHUN 2019

Kewajiban memakai APD telah diatur dan tercantum dalam Permenakertrans/08/2010 tentang Alat Pelindung Diri. Pekerja pada unit *extruder* 90% tidak menggunakan APD sehingga dapat menimbulkan kecelakaan. Tujuan penelitian ini untuk mengetahui faktor-faktor penggunaan alat pelindung diri (APD) pada pekerja unit *extruder* di PT. Federal Plastik Indonesia tahun 2019.

Penelitian deskriptif dengan pendekatan survei. Pengumpulan data dilakukan dengan observasi dan wawancara. Besar populasi pekerja 1 unit *extruder* dengan jumlah sampel sebesar 38 pekerja. Data dianalisis menggunakan tabel distribusi frekuensi dan tabel silang.

Hasil penelitian nilai pengetahuan (55%) kurang, sikap (66%) baik, tindakan (66%) kurang, ketersediaan APD (76%) baik, pengawasan (100%) baik, peraturan (100%) kurang dan (53%) tidak menggunakan APD.

Faktor-faktor tersebut sebagian besar disebabkan karena tidak adanya pengawasan berupa diadakannya pelatihan atau *briefing* terkait penggunaan APD yang diberikan oleh pihak perusahaan. Oleh karena itu peneliti menyarankan agar perusahaan mengadakan pelatihan dan *briefing* atau *safety talk* setiap pagi dan setiap pergantian *shift* kerja dan pihak perusahaan wajib melakukan pengecekan kondisi alat pelindung diri (APD) serta mengupayakan pemeliharaan lingkungan kerja sehingga tercipta lingkungan yang nyaman bagi pekerja.

FACTORS FOR USING PERSONAL PROTECTIVE EQUIPMENT (PPE) IN EXTRUDER UNIT WORKERS IN PT. FEDERAL PLASTIC INDONESIA IN 2019

The obligation to use PPE is regulated and listed in Permenakertrans / 08/2010 concerning Personal Protective Equipment. Workers on the extruder unit 90% do not use PPE so that it can cause accidents. The purpose of this study was to determine the factors of use of personal protective equipment (PPE) in extruder unit workers at PT. Federal Plastics Indonesia in 2019.

Descriptive research with survey approach. Data collection is done by observation and interviews. The population of workers is 1 extruder unit with a sample size of 38 workers. Data were analyzed using frequency distribution tables and cross tables.

The results of the knowledge value (55%) were lacking, attitude (66%) was good, action (66%) was lacking, availability of PPE (76%) was good, supervision (100%) was good, regulation (100%) was lacking and (53%) do not use PPE.

These factors are largely due to the absence of supervision in the form of holding training or briefings related to the use of PPE provided by the company. Therefore the researcher recommends that companies hold training and briefings or safety talk every morning and every shift of work shift and the company must check the condition of personal protective equipment (PPE) and strive to maintain the work environment so that it creates a comfortable environment for workers.
